At this year's ALRC AGM, which will take place at 10.00am on the 14th March 2015 at The Oaks Farmhouse, NFU Mutual Headquarters, Tiddington, Stratford-upon-Avon, CV37 7BJ the following members of the ALRC Council are due to stand down under the three year rotation and are seeking re-election:

Debby Darby has been co-opted in 2014 onto the ALRC Council and seeks election to join the ALRC Council.

The following members of The Scrutineering & Off Road Committee are also due to stand down under the three year rotation system:

Andrew Flanders and Gary Campbell do not wish to be re-elected onto the S&ORC but will continue in their roles as an ALRC log book scrutineer.

Dave Moore has stood down from the S&ORC and as a log book scrutineer.

Dave Southcott has been co-opted in 2014 onto the S&ORC and seeks election to join the S&ORC

A nomination has been received for Dave Canham to join the S&ORC.

Any further nominations for either committee need to be received at the above address by the 13th March 2015 or in person at the meeting.

Nominations must be received on club headed paper from a member club with signatures from a proposer and seconder. Members are reminded that to be elected on to either committee means a commitment to attend the meetings held three times a year at Tiddington.

Council meetings are held in February, June and October, General and S&ORC meetings are held in March, July and November. If you require any further information then please contact me.

Voting will take place at the meeting and votes for both committees will only be accepted from clubs that have paid their 2015 ALRC subscription prior to the meeting. Votes should be given by the club secretary or named delegate from the club.

Included with this letter is a copy of the ALRC financial statement for the year ending 31st December 2014. You will see from the accounts that we have been fortunate again to obtain sponsorship from the NFU Mutual and are indebted to them for the free use of their buildings to hold our meetings. Derek Spooner will discuss this financial statement further in his report at the forthcoming ALRC AGM.

Also at this meeting there will be a short introduction from the Towy Land Rover Club who have applied to join the ALRC as a non-competitive club. A vote for acceptance will be taken by those member clubs present at the meeting.

Clarification to the ALRC Supplementary Competition Regulations

Following the recent changes in the law regarding the displaying of tax discs, the ALRC Council at their meeting on the 21st February 2015 agreed the following clarification to the ALRC Supplementary Competition Regulations which takes immediate effect.

M.3. DOCUMENTATION

M.3.1. Where required by law all entrants must possess a current VOSA Test Certificate (generally known as the MoT) and a valid Vehicle Excise Licence or equivalent MoD documentation relating to the vehicle being entered. (Implemented 21st February 2015)

I would like to take this opportunity to remind all competitive clubs that the voting slip for the rule change proposal sent out previously, needs to be submitted prior to the start of the meeting, either by post or in person.

Caravan & Camping Permits

I have also included a copy of the new caravan and camping application form that should now be used to apply for any permits and would be grateful if they could be sent direct to Debby Darby's address that appears on them. Please ensure that all the correct boxes are filled in as applications can be delayed by incomplete forms being submitted.
